The Company received Listing and Trading approvals from the stock exchanges for 80,000 Equity Shares during the quarter ended September 30, 2024 and the said shares had also been credited in the Allottee's demat account. However, the same are subject to lock-in as per the SEBI (ICDR) Regulations, 2018.
