

## **Important Notice for holders of Physical Securities (Equity Shares) of Khadim India Limited**

7. Specimen signature.

Folios wherein any one of the aforesaid documents / details are not available on or after October 01, 2023 or any other date as may be specified by SEBI, shall be frozen by the Registrar and Transfer Agent (RTA) of the Company.

- SEBI, vide Circular No. [SEBI/HO/MIRSD/MIRSD RTAMB/P/CIR/2022/8](#) dated January 25, 2022 has mandated issuance of securities in dematerialized form while processing the following service request:

1. Issue of duplicate securities certificate;
2. Claim from Unclaimed Suspense Account;
3. Replacement / Renewal / Exchange of securities certificate;
4. Endorsement;
5. Sub-division / Splitting of securities certificate;
6. Consolidation of securities certificates / folios;
7. Transmission; and
8. Transposition.
